Strongly understands the importance of healthy nutrition and daily activity, as well as how it supports individuals with mental illness and addiction disorders towards their recovery. Coordinates and facilitates health services, groups, classes, and presentations in order to promote health and wellness among this population. Provides hands-on, intensive skill-building interventions and supports to clients to enrich and achieve an overall level of independence and well-being. Performs other duties as assigned.

Works collaboratively networking with area providers and assists clients in seeking and sustaining employment goals. Prior knowledge of addiction and mental illness preferred.
